Building and Equipment:

• Furnace in the hall – We have an estimate from FHC to raise the HVAC system off the ground. In talking with them further, it was stated that as long as they were reworking duct work, they could install both a heat vent into the election room along with a cold air return. They would include this work with no increase in cost of the estimate.

A motion was made to accept the estimate from FHC to raise the HVAC system in the amount of \$4,860.00. Seconded by Nickerson. All ayes. Motion carried.

Currently we have a balance of \$5,731 in the repair budget which will cover this but we may need to have a budget modification at a later date.
