Treasurer's Report - Karmen Nickerson

Clerk's Report - Sheri Babcock

- May 7th election went smoothly. We processed a total of 592 ballots out of the total 2,536 voters.
 About a 23% turnout. 269 of these were AV ballots with the remaining 323 as walk in voters.
- Delton School district bond proposal was passed for 23,215,000. This proposal also passed in our township.
 - Hastings School district bond proposal was declined for 9,990,000. This proposal also lost in our township.
- This election was a consolidated with Johnstown hosting Bedford and Assyria's Hastings school district voters. This will be the last consolidated election as the county as decided that it is no longer beneficial to consolidate under the new regulations of Prop 3.

- We processed two new voter registrations on election day.
- Election cost reimbursement is being processed to school districts for the May 7, 2019 election.
- Waiting to see if anything will be on the August election. Deadline to file is May 14th.
- Bank balance transfers were completed to begin first new month of fiscal year as budgeted.

Bristol Lake Channel – Special Assessment for weed control. Resident Cindy Hall representing the Bristol Lake Channel residents was present to proceed with the process of getting the special assessment started. Petitions were given to her to start getting signatures. 12 of the 15 residents have agreed to sign the petition and the remaining 3 still need to be contacted but are mostly likely in favor anyway. They will return petitions as soon as possible. We will begin getting with the lawyer as the district has expired and will have to be set up again. The district and estimates will most likely be set up for 5 years.

Computer Upgrades: We have estimates for both the poll-book replacement lap for \$765.00 and for the server for \$4,784.00. The Laptop budget was set at \$750.00. We will need a budget amendment of \$15.00 to cover this replacement. A motion was made by Warren to approve the purchase and budget amendment for the poll-book laptop. All ayes. Motion carried.

The server budget was \$650.00 which we knew was low. We will need a budget amendment of \$4,134.00 to cover the entire cost of the server and installation.

A motion was made by Warren to approve the replacement of the server and the budget modification in the amount of \$4,134.00 to cover the additional cost and installation. Seconded by Nickerson. All ayes. Motion carried.

<u>Pay Bills</u>: A motion was made by Warren to pay the bills in the amount of \$25,400.78 as presented. Seconded by Babcock. All ayes. Motion carried.
